### CUSTOMER WAIVER OF LIABILITY FORM

This is a legal document that must be read and agreed to in full, otherwise use of recreational services will not be permitted.

I, as a user of Camp Street Climbing (CSC) facilities or as parent/legal guardian on behalf of my child who is under 18 years of age, wish to utilise the rock climbing recreational services supplied by Camp Street Climbing Pty Ltd to its patrons. I understand that my/my child's use of the recreational services supplied by Camp Street Climbing as set out herein:

1. I understand that this is a legal document that affects my rights or my child's rights.	INITIAL
2. I accept full liability for my actions and for the actions of any person in my care while I am at CSC.	INITIAL
3. I understand that bouldering is an adventure sport that requires a significant degree of physical exertion and a degree of inherent physical risk, including death and physical injury, and I believe that I am physically capable to participate and do so of my own free will.	INITIAL
4. I agree to provide CSC with all relevant and necessary information, and update if anything changes, that relates to my/my child's physical health and capacity to participate in strenuous exercise.	INITIAL
5. I understand that if CSC is not provided with all relevant and necessary information about me/my child's health and capacity it will not be able to fully appreciate the risk of harm to me/my child in providing instruction and in allowing me to participate in the recreational services.	INITIAL
6. I understand and agree to obey at all times the rules displayed at the bouldering centre, and to adhere to any instruction issued by the staff or agents of Camp Street Climbing Pty Ltd and I understand that I may be asked to leave the premises if I fail to observe these rules.	INITIAL
7. I warrant not to participate while affected by alcohol and/or drugs and I understand that participating in any activities at CSC after I have consumed any alcohol and/or drugs will remove any and all liability from Camp Street Climbing Pty Ltd, its directors, employees, volunteers, agents and businesses.	INITIAL
8. I agree to immediately notify CSC upon sustaining/my child sustaining any injury whilst using the recreational services supplied by CSC irrespective of the circumstances in which such injury was sustained and where requested	INITIAL

by an employee of CSC shall provide such notification in writing.	
9. I understand that this waiver of liability form is ongoing and will apply to all future occasions in which I participate at CSC.	INITIAL
10. I am aware that it is a condition of participation that Camp Street Climbing Pty Ltd, its directors, employees, volunteers, agents and businesses are absolved from any claims, costs, damages and any other liabilities they may have for injury or death suffered by me, and I acknowledge that this waiver represents a legal release and discharge of legal responsibility to Camp Street Climbing Pty Ltd, its directors, employees, volunteers, agents and businesses except where the injury or death is due to gross negligence on the supplier's part. ('Gross negligence' is defined in the Fair Trading (Recreational Services) Regulation 2004.)	INITIAL

By signing this Waiver and Release Form- a) I expressly state that I have read this document and I fully understand and accept its contents; b) I warrant that all of the information contained in this application is true and correct; and c) I acknowledge that Camp Street Climbing has relied on the accuracy of this information in registering me.
